### **General Rules and Regulations for the 2018 Season**

Permission to participate in the Wilmington Wilmo a Go-Go Car Show (WWGCS) can be revoked by the City of Wilmington at any time. These rules are mandatory for all vendors participating in the WWGCS and are part of the agreement for participants.

#### **Tents**

Vendors are strongly encouraged to obtain a 10x10 pop-up (EZ-Up) tents as there is no shade/rain protection at the Parking Lot. All vendors must have weights available in case of strong gusts of wind. **Tents with guide/support lines are strictly prohibited.** Please contact WWGCS Manager for more information.

#### **Tables and Chairs**

All vendors are required to supply their own tables and chairs.

#### **Sales People at the Tents**

People knowledgeable of the items for sale must be present in vendor tents at all times during the WWGCS. Children under the age of 16 will not be allowed to sell unless accompanied by an adult knowledgeable of the items for sale. Vendors must be dressed appropriately for working with the public.

#### **General Rules/Code of Conduct**

- **All vendors are responsible for liability insurance and compliance with any/all requirements of the State of Delaware.**
- All items for sale must be marked as such with clear pricing.
- Any scale used in determining pricing will display a current legal inspection sticker.
- All vendors will display their products in a clean and safe manner.
- At the close of the car show vendors will clean their immediate area and remove all boxes, packing materials and trash.
- Vendors should operate their business in a professional manner at all times.
- This is not a discount show. Anyone engaging in price wars may be removed from the car show. Fraudulent, dishonest or deceptive merchandising will result in removal from the car show.
- Fees collected will be used for advertising and maintenance of the show area and other operational expenses.
- The WWGCS staff (market manager, assistants, volunteers, and community service workers) and WWGCS vendors and customers will not be subject to language or actions considered to be abusive, profane, threatening or harassing.
- Solicitation for products, services, or charitable contributions, not specifically addressed as a market commodity, or by vendors other than market vendors, will not

be permitted, except with special permission granted by the WWGCS staff and the City of Wilmington.

- All vendors will be responsible for the actions of their employees and/or agents.
- Possession of firearms, fireworks, gambling, use of alcohol or drugs, or disorderly conduct by a vendor or his/her employees or agent also constitutes a violation of Wilmo a Go-Go rules.

**Insurance Waiver 2018**
